

TRANSPORTATION

DISTANCE TO OTHER CITIES

Sheboygan County is a one-hour drive to Milwaukee and Green Bay, and less than a 3 hour trip Chicago. Interstate 43 and State Highways 23 and 57 make are the main four-lane right-of-ways connecting Sheboygan County to the world.

ROADWAYS

Sheboygan County has over 1,380 miles of roads, including Interstate 43, which bisects the County and makes travel to Milwaukee and Chicago, and to Green Bay, effortless. Seven state highways are located in Sheboygan County, including the four-lane State Highways 23 and 57.

COMMERCIAL TRUCKING

Trucks carry 83% of all manufactured freight transported in Wisconsin. Sheboygan County has several trucking and warehousing firms.

RAIL

Sheboygan County is served by both the Wisconsin and Southern Railroad (WSOR) and Union Pacific Railroad (UP). The WSOR has a transloading site in Plymouth. The UP serves a refrigerated warehouse in Cedar Grove.

AIR PORTS

Sheboygan County Memorial Airport (SBM) is owned by the County. SBM is a Transport/ Corporate (T/C) airport and can serve 60,000 pound aircraft with wing spans less than 80 feet in length. The primary runway is

concrete and is nearly 6,800 feet long by 100 feet wide. Commercial passenger and air freight services are available at General Mitchell International Airport (Milwaukee) and Austin Straubel International Airport (Green Bay), an hour drive-time away.

SPACEPORT

Sheboygan has the only licensed spaceport in the Midwest capable of launching sub-orbital rockets. The Great Lakes Aeronautics and Space Education Center (GLASEC) was established to take advantage of this unique attribute.



PORTS

Two modern commercial port facilities are located within an hour: Milwaukee and Green Bay. These modern port facilities link cargo vessels with land based transportation. Ports in Manitowoc (25 miles) and Milwaukee (55 miles) are served by ferries that travel across Lake Michigan to Ludington and Muskegon, Michigan respectively.

UTILITIES

Sheboygan County's utility infrastructure is vital to the success of our current businesses. Sheboygan County's infrastructure is cost-effective and forward-thinking, with many municipalities sharing water and sewer systems to keep service charges down. In addition, there are no utility taxes in Sheboygan County.

ELECTRICITY

Electric Service in Sheboygan County is provided by Alliant Energy, We Energies (Wisconsin Electric Power Company), Plymouth Utility (WPPI or ATC), and Sheboygan Falls Utility. There are two electric generation plants, one coal fired and one natural gas, in the county. High voltage power transmission is provided by American Transmission Company (ATC). WATER

Sheboygan County has a plentiful and inexpensive water supply, due to Lake Michigan. Sheboygan County also enjoys lower water rates than many in the surrounding region. There are 15 municipal water systems within Sheboygan County. Twelve of the fifteen municipal water systems have deep wells to draw groundwater accounting for 40% of Sheboygan County's water supply. The communities of Sheboygan, Sheboygan Falls and Kohler obtain their water supply from Lake Michigan. In 2005, Sheboygan County used nearly 25 million gallons of water per day. NATURAL GAS

Natural gas service is provided in Sheboygan County by Wisconsin Public Service and WE Energies. Natural gas pipelines even supply a 345K electric generation plant. For more information on the natural gas service area please visit the SCEDC website.

WASTEWATER TREATMENT FACILITIES

Sheboygan County has16 municipal-owned and 18 industrial wastewater treatment facilities. Visit the SCEDC website to learn more.

TELECOMMUNICATIONS

Sheboygan County is home to a wide range of telecommunication providers. Landline telephone service carriers in Sheboygan County include Verizon, AT&T and TDS. There are also over 140 wireless towers throughout Sheboygan County, providing comprehensive coverage and service to wireless customers. AT&T, Charter Communications and Time Warner Cable provide digital/high-speed internet.

Nearly 72% of Sheboygan County's housing units are owner-occupied. The median housing value in Sheboygan County is estimated to be \$149,700, which is \$43,000 less than the United States estimated median home value. At the same time, Sheboygan County Income is higher than the national average, the reason for high home ownership rates.



HIGHER EDUCATION

Sheboygan County has a little bit of everything when it comes to higher education.

- Lakeshore Technical College offers 2-year technical degrees.
- University of Wisconsin-Sheboygan offers 2- and 4-year degrees.

- Marquette University offers an executive MBA program hosted in Kohler, WI.

HOSPITALITY

The **Midwest's only** AAA Five Diamond Resort/ Hotel, The American Club, is located in Sheboygan County.

There are well over a dozen lodging sites in Sheboygan County ranging from extended stay to luxury accommodations. Sheboygan County also has two conference centers.

GOLFING

Sheboygan County is the place for golf. *Golf Magazine* ranked Sheboygan County **one of the top seven golf destinations in the world.**

Golf Digest Magazine has ranked four Sheboygan County golf courses in the top 100 golf-courses in the United States.

In 2010, *Golf Digest Magazine* ranked two Sheboygan County golf courses to be the top 20 golf courses in the world.

Sheboygan County is home of the 2012 WPGA Championship, 2015 PGA Championship, and 2020 Ryder Cup.

CULTURAL

Sheboygan County has two performing art centers, one in Plymouth and the other in Sheboygan. Sheboygan also has a symphony orchestra. There are three museums in Sheboygan County: the Wade House, Sheboygan County Historical Museum, and the Above and Beyond Children's Museum.

Two things that make Sheboygan County stand apart are the John Michael Kohler Art Center and the Great Lakes Aerospace science and Education Center.

CONFERENCE CENTERS

Both the Osthoff Resort in Elkhart Lake and Blue Harbor in Sheboygan cater to corporate events. Both offer large conference rooms, accommodations for guests, and catering services.

Both centers are situated on bodies of water providing guests with a relaxed setting to do business and near-by recreational opportunities.
